This is an exciting time as I begin to learn the duties of this office. As I talked with many of you at the WALA May Luncheon, I realized how proud I am to be part of the Wichita area library group. I have been a member for the ten years I've been at the Wichita State University Libraries, but until now have not had time to commit to the development of WALA as an organization that can provide even more professional support to its members. And, trust me – we have so much potential!

I hope you will take seriously Sharon's request for volunteers to review the WALA By-Laws and give her a call or e-mail volunteering to help. This is a much-needed task, but one that can be done largely via e-mail.

I am very interested in statewide advocacy. For the past two years, I have been a member of the Kansas Library Association's Legislative Committee. You'll be relieved to know that in this past legislative session, the libraries of Kansas emerged intact. To quote **Mona Carmack**, 2004-2005 Legislative Committee Chair, "we didn't lose any money

and no restrictive legislation was passed." For the 2005-2006 session, we can rely on **Cindy Berner-Harris**, Director of Wichita Public Library, to keep us posted on major library advocacy issues in Kansas.

My goal is to get to know all of you better and to build membership. I encourage all of you to reach out to those who have not realized what a supportive community we have in WALA. I would also like to develop, along with Sharon, an assessment tool so we can evaluate what our members appreciate most about WALA, what areas



could be reevaluated and where we should be building for more support to members. In the meantime, please let Sharon and me know what your needs are and how we can help you in your profession.

The **KLA Legislative Committee** is just beginning planning for the next legislative session. Two general issues have emerged so far: 1) Push for funding to provide 10% of local library budgets from the state appropriation.

2) Continue to discuss and develop a new funding mechanism/formula.

In addition, the Committee plans to develop Library Advocacy Workshops statewide through the Kansas Library Systems Structure. SCKLS Director, **Paul Hawkins**, and Wichita Public Library Director, **Cindy Berner-Harris**, are both on this committee for 2005, so the WALA News will continue to provide updates on these issues.

Wrap-up of 2004-2006 KLA Legislative Committee

From Chair, *Mona Carmack*, Director, Johnson County Library

Looking back at the 2005 session of the Kansas Legislature and considering the various distracting issues, the libraries of Kansas emerged intact. We didn't lose any money and no restrictive legislation was passed.

- The grants-in-aid appropriation was not reduced, and remains at \$2,393,562. ILDP remains at \$624,670. Talking Books Service remains at \$386,105. However, the operating budget for the Kansas State Library will be reduced again by \$28,000 for 2005.
- HB2624, which started out as HB2605, was vetoed by the Governor and was not over-

ridden. This is the "Auburn" bill which allowed the City of Auburn to exempt itself, should it so wish, from the Topeka Shawnee County Public Library district. This bill was voted out of the Senate Elections and Local Government Committee under a different bill number from which all content from the previous bill was removed. The bill was then approved by a conference committee and passed. Therefore the only information available on the bill was from the House Journal rather than the tracking database of legislation.

- HB2420, the filtering bill, was passed in the House with three

amendments. The first amendment provided that the city or county attorney could bring suit, rather than "any citizen." The second amendment prohibits the circulation of R-rated videos to any person under 18 years of age, and the third amendment provides that the act does not go into effect until the state provides funding to pay for filtering software. The bill passed easily in the House because representatives felt it was acceptable with the third amendment. The bill died in a Senate committee, but will be resurrected next year.

WALA connection to Harry Potter

As a student at Robinson Middle School, in the pre-International Baccalaureate Program, community service hours are an important part of the students' work. Because of his work with WALA, Matthew was able to win an award for having the most service hours for the 2002-2003 school year.

News from your Kansas State Library Advisory Commission Representative

After over 22 years of service as the State Librarian, **Duane Johnson** has resigned to pursue other interests. His resignation is effective July 31, 2004, and he is busy this month assigning on-going projects to others in the organization. We will miss Duane's leadership.

System librarians from each of the seven Kansas regional library systems presented their proposed 2005 annual plans and budgets to the State Library Advisory Commission on June 18. An aging population of users, funding issues, and a decline in reference questions were common to most systems. **Paul Haw-**

kins, SCKLS' new director, presented for our region. A major change proposed for 2005 by SCKLS is the creation of a staff position for Member Library and Staff support. The report described the position as being "accessible by a toll-free number for member library basic computer and technology troubleshooting. In addition, the position will provide support for staff technology, SCKLS website maintenance, and communications support such as the annual compilation and printing of the SCKLS Directory for member libraries. Some duties of the eliminated Graphic Arts position will be incorporated into this new position."

Good News from Derby Public Library

Derby Public Library receives \$2,500 grant for "Book Buddy" program to help purchase children's literature books. The grant will allow the library to begin a program that

will pair a high school age volunteer with a younger student. The two will read to each other in the library fostering an environment for improved reading skills, according to **Judy Bennett**, director of the library.

The program is still in the developmental stages and has many details to be worked out before it actually begins, according to **Carri Fry**, children's coordinator with the library. Fry said the staff at the library has heard of similar programs at conferences and thought it sounded like a good way to utilize the teen volunteers year-round. Derby librarians hopes that the new program "Book Buddy" will help to involve more special needs children in a summer reading program.

Wichita Public Library to Host *At the Controls*

To tie into Wichita's Aviation Festival (September 24-26), the Wichita Public Library is hosting *At the Controls: The Smithsonian National Air and Space Museum Looks at Cockpits*,

a traveling exhibition from the Smithsonian Institution Traveling Exhibition Service (SITES). The exhibit offers library customers a unique perspective of cockpits from some of the world's most impressive air and spacecraft. *At the Controls* will open at the Wichita Public Library (Central Library, 223 S. Main, 316-261-8500) on August 7 and will remain on view through September 26, 2004.

"At the Controls" features 20 large-format color photographs of historically significant cockpits, such as the Wright brothers' 1903 Flyer; the *Enola Gay*, a Boeing B-29 Superfortress; and the Mercury *Friendship 7*. The cockpits in the exhibition were selected because their instrumentation panels vividly illustrate the development and refinement of aviation technology. Additional information and complete views of the air and spacecraft accompany each photograph. An

opening reception will be held at the Central Library on Saturday, August 7 from 2:00 – 4:00 p.m. with a talk and question/answer session, *What Instrument is That*, hosted by the Kansas Aviation Museum. Additional events include *Learning to Fly*, a discussion by Yingling Aircraft on Sunday, September 12, from 2:00 – 3:00 p.m., on becoming a pilot and a series of films on Sunday, September 19, 2:00 – 4:00 p.m., that show pilots at the controls. A contest encouraging visitors to pick their favorite cockpit for a chance to win free flying lessons will continue through the exhibition.

The exhibit was developed by the Smithsonian Institution Traveling Exhibition Service (SITES) and the Smithsonian's National Air and Space Museum. The Wichita Public Library's participation is made possible by the Estate of Olive Ann Beech.

Summer @ the Wichita Public Library

Summer at the Wichita Public Library is hectic: the Library offers around 30 programs for youth per week during June and July, several designed and performed by staff. With such traditional favorites as Nursery Rhyme Time, Toddle Time, and Preschool Storytime, children continue to enjoy establishing relationships with the Library at a young age.

Special events and visiting performers, such as magician **Shawn Reida**, Children's Theatre of Florida, musician **Monty Harper**, and Yo-Yo World Champion **Brent Dellinger** add to the excitement. Teens too have plenty to do in the summer at the Wichita Public Library: they can join a book discussion, do craft projects, and learn all about (and sample!) chocolate. Of course,

WICHITA STATE UNIVERSITY LIBRARIANS at the American Library Association Annual Conference in Orlando, Florida

A group of Wichita State University librarians participated at the ALA Annual Conference in July 24-July 30 in Orlando, Florida. Here is information they shared with the WALA News, and we plan to have more feedback on the ALA Annual Conference 2004 in the next issue.

Standards and Assessment for Academic Libraries

An ALA day-long pre-conference on Standards and Assessment for Academic Libraries presented by **Bill Nelson**, Augusta State University, and **Bob Fernekes**, Georgia Southern University, yielded information applicable to other libraries as well. Basically, assessment of the outcome of library activities equals information literacy. If the patrons we serve are able to identify their needs for information and locate, evaluate, and use it, they are receiving value from the library. "Information" includes advice on which books make good beach reads. To measure value, libraries need to obtain behavioral data instead of collecting opinions.

"Outcome assessment" goes beyond measuring inputs (number of items added to catalog, etc.) and outputs (number of items checked out, etc.) to measuring the impact of inputs and outputs. An example would be to find out if the patrons found what they wanted. This type of information would give the library an idea if their collection development policies meet the needs of their patrons and if library workers are able to competently suggest pertinent Web sites.

Technical Services Librarians@ALA

Sha Li Zhang, WSU Associate Professor and Head of Technical Services, had a very busy schedule at the 2004 ALA Annual conference in Orlando, including planning an ALCTS research program at the ALA 2005 in Chicago, serving as Treasurer/Secretary of the International Relations Round Table, and attending her first ALA Council meetings.

Sha Li also brought back information of a new development on Meridian, electronic resource management system by Endeavor. Sha Li participated in a focus group and demo session on this product and visited the vendor's booth. If it is completed, this product will help library maintain useful records of electronic resources such as license/agreement, ILL/e-reserve protocols, right/use information, and holding and acquisitions data. At the focus group meeting, Sha Li offered input on work flow issues and on how this new module can extract cataloging data from Voyager online cataloging system so that duplicate data input can be avoided.

Susan Matveyeva, Assistant Professor & Catalog Librarian gave the presentation "Cataloging Quality as a Communicative Process" at the ALCTS Cataloging Norms Discussion Group and facilitated the round table at the Creative Ideas in Technical Services Discussion Group on the topic of quality control in cataloging. Susan also attended a number of sessions of general and cataloger's interests on the topics of the effect of contempo-

rary way of learning on libraries, authority control, subject access to library materials, and development of cataloging rules. The most impressive news in a cataloging field are the new edition of cataloging rules, AACR3, that will replace the current "catalogers' Bible" in 2007 and development of Virtual International Authority File that creates the worldwide database of authors.

The sessions and presentations showed the steady increasing role of electronic resources. It impacts general public as well as librarians as users. For example, catalogers that use electronic versions of Classification-Web and Cataloger's Desktop, the popular packages of cataloging standards, refuse to go back to the paper versions of these manuals. One of the reasons is the amazing abilities of electronic resources to collocate information via electronic links.

Academic librarians might also be interested in the session on subject access to theses and dissertations attended by **Ted Gemberling** and **Susan Matveyeva** where reference librarians and catalogers discussed the usefulness of subject headings access to research materials. This relatively "narrow" topic attracted very serious experts, such as **Cathy Gerhart**, OLAC President, and **Diane Wazine-Goetz**, OCLC Research Scientist, partly, because of importance of research materials, and partly, because of the core value of subject access for cataloging.

“Proposed Kansas Library Laws Revisions”

Roger Carswell, Director of the Southeast Kansas Library System, will present a statewide proposal for revising public library laws and governance. The proposal would change the funding mechanism for public libraries and SCKLS from a property tax to a sales tax; has the potential to increase funding to public libraries up to 10%; expand the definition that allows for the formation of district libraries and elected district library boards; and provide for the establishment of a Sedgwick County Library System. Before it would be enacted, the proposal would require action by the Kansas Legislature. This is an opportunity for SCKLS public, academic, school and special members as well as public library board members along with interested persons to learn about and comment on the proposal.

“Kansas Libraries’ 20/20 Potential: Planning for Statewide Library Services”

According to Kansas State Library Literacy Coordinator Vikki Jo Stewart, “20/20 Potential denotes several things, it is visionary, future-oriented and believes there are possibilities.” The Kansas State Library and South Central Kansas Library System invite SCKLS member librarians, public library board members and interested library advocates to participate in an evaluation and planning process for statewide library services. Currently, well-known statewide library services include KANED, Blue Skyways, Kansas Library Catalog, Kansas Interlibrary Loan Circuit Network, Kansas Library Card, KANGUARD, Library Service and Technology Act grants and Interlibrary Loan Development Program grants. Help evaluate these library services and plan for the future.

You are welcome to attend one or both sessions depending on your interests. Morning and afternoon refreshments are complimentary and an optional lunch will be provided for a fee of \$7.50. **Four hours of continuing education credit in the Library Employee Education Program (LEEP) will be offered to interested participants.** For additional program or registration information contact Nancy Malone, 800-234-0529, Ext. 149 or e-mail nmalone@sckls.org. Wichita State University offers

School Library Media Endorsement Program

Successful completion of this program will result in eligibility to add school library media endorsement to a Kansas teaching certificate. Certified Kansas teachers completing all 24 hours of required library media courses and both children's and adolescent literature will qualify for licensure in library media at the K-12 levels. While the children's and adolescent literature courses can be taken at the undergraduate level, the library media courses must be taken at the graduate level. Therefore, prospective students must make application for admittance to the Graduate School at Wichita State University. Application can be made in Curriculum and Instruction, non-degree category A (G41P) status if you only intend to take the courses required for library media endorsement. If you also want to use part of the library media courses within a Master's degree in Curriculum and Instruction, you should apply for degree status in Curriculum and Instruction (G17N). **A Master's degree in any area is required to obtain Kansas licensure in School Library Media at the end of the program.** The library media licensure program is housed on the West Campus of WSU, which is located at Central and Ridge Avenues next to Food4Less. This location offers better access to technology, an integral part of the library media program.

The first course for the 2004 cohort group, CI 716 Introduction to Library Science, is offered this summer from July 5 to July 30 at the WSU West Campus. Linda Paul and Rosemarie Donohoe, library teachers at Wichita North High School, are the instructors. Future summer courses will be scheduled at the convenience of both the instructors and the students. During fall and spring semesters, courses will be offered on Tuesday evenings from 5:00 to 6:55 p.m. at the WSU West Campus. As only one section of each course will be offered in any given semester and each course will be offered only once during each cohort group, flexibility on your part will be required.
